

Owner Builder Permission to Sell Application

Section 20.1(2) of the Homeowner Protection Act allows an owner builder to apply to the Registrar, BC Housing for permission to sell or offer for sale a new home under construction or within the prescribed period of time (12 months) after the new home has been built if the Registrar is satisfied that the person would suffer undue hardship if the permission is not granted, and the person pays the prescribed fee (\$100.00). Under section 20.1(3) the Registrar may impose conditions on a permission granted under section 20.1(2).

APPLICATION CHECKLIST AND INFORMATION

The following must be mailed to our office:

- One fully completed copy of the application. Please print clearly in black ink. The application must have the <u>original</u> signature of the owner builder.
- □ Non-refundable payment in the amount of \$100.00 for the application fee (cheques payable to BC Housing Licensing and Consumer Services).
- ☐ Copies of all supporting documentation.

For applicants claiming financial hardship, supporting documentation must include:

- Proof of income for all household members (pay slips and tax returns)
- · A copy of BC Assessment Authority notices for each property where the owner builder is named on title
- · Completed Mortgage Confirmation Certificate(s) for each property where the owner builder is named on title
- · Statement of Business Activities, if owner builder is self-employed
- Company financial statement if owner builder is the primary or sole owner of a limited company
